I would like the charity to treat all donations I make from the date of this declaration until I notify you otherwise as Gift Aid donations.

I am a UK taxpayer and understand that if I pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all my donations in that tax year it is my responsibility to pay any difference. I will inform you if I cease to become a UK taxpayer.

#### Notes

- 1. You must pay an amount of tax and/or capital gains tax that is at least equal to the tax that the charity reclaims on your donations in the tax year (currently 25p for each £1 you give).
- 2. You can cancel this declaration at any time by notifying the charity.
- 3. If in future your circumstances change and you no longer pay tax on your income and capital gains that is at least equal to the tax that the charity reclaims, you must cancel your declaration.
- **4.** If you pay tax at the higher rate you can claim further tax relief on your Self-Assessment tax return.
- **5.** If you are unsure whether your donations qualify for Gift Aid tax relief, ask the charity, or ask your local tax office for leaflet IR 65.
- 6. Please notify the charity if you change your name or address.
