#### Notes

1. You must pay an amount of tax and/or capital gains tax that is at least equal to the tax that the charity reclaims on your donations in the tax year (currently 25p for each £1 you give).
2. You can cancel this declaration at any time by notifying the charity.
3. If in future your circumstances change and you no longer pay tax on your income and capital gains that is at least equal to the tax that the charity reclaims, you must cancel your declaration.
